*****Where PET is used for this purpose, the producer / retailer must demonstrate that the containers are designed for multiple uses and that the number of filled containers exceeds the number of empty containers. Failure to do so will be viewed as a breach of the DRS regulations where the volume of these containers is between 150ml and 3 Litres.

******Liquids that can be consumed for non-medical reasons will be considered beverages.
