## 1. Introduction

- 1.1. This policy applies to any user of the Re-turn.ie website whatsoever.
- 1.2. The Re-turn website use cookies helps provide you with a good experience when you browse the Re-turn website and also allows us to improve our website.
- 1.3. Deposit Return Scheme Ireland (the “**Company**”) respects the privacy of all visitors to our website. This Cookie Policy outlines Re-turn’s policy concerning the use of cookies and similar technologies (“**Cookies**”) on our website and any of its subdomains [and/or apps].
- 1.4. A “**Cookie**” is a small piece of data or text file that may be stored on your computer or mobile device when you visit a website. It allows a website to “remember” your actions or preferences over a length of time.
- 1.5. We also work with other companies who use tracking technologies to serve ads on our behalf across the internet. These companies may collect non-personally identifiable information about your visit to the Re-turn website and about your interaction with our communications, including advertising and e-mails.
- 1.6. “**Tracking Technology**” in this context means the use by Re-turn’s websites and mobile applications of a variety of technologies such as cookies, software development kits and other tracking technologies including pixel tags and web beacons. Where this policy refers to cookies, this also include the above such tracking technologies mentioned.

## 2. How Re-turn uses Cookies


- 2.1. Re-turn’s website uses cookies for several reasons which can include:
  - To understand the use of our website, such as the visitor numbers and in what way visitors interact with the website.
  - To help visitors navigate the website.
  - To make improvements to our website.
  - To help us and our advertising networks to make advertising relevant to you and your interests.
- 2.2. Some cookies are placed by third party services on Re-turn’s website pages also.

- 3.1. The law<sup>1</sup> states that we can store cookies on your device if they are strictly necessary for the operation of this site. For all other types of cookies, we need your permission.
